Project Title for Ph.D:

1. Self Emulsifying Drug Delivery Systems for Poorly Soluble Drugs.

A large number of new drug products have solubility problems. They are poorly water soluble and have very less bioavailability. To overcome solubility problems several traditional method are adopted. Recently self emulsifying drug delivery systems (SEDDS or SDS) are introduced to improve the solubility of poorly soluble drugs, which in turn increases the oral bioavailability of drugs.

SEDDS are mixtures of oil, surfactants and co-solvents or co-surfactants. Oil can be synthetic or natural source, surfactants can be solids or liquids, co- solvents or co-surfactants can be single or multiple solvents. These SEDDS should form oil-in-water emulsions or Self micro-emulsifying drug delivery systems (SMEDDS) and these formulations pass through stomach easily. Once they reach stomach, availability of drug will be more in GI tract. These formulations reduce stomach side-effects like irritation, nausea etc., because the drug is in soluble form in lipid based systems. These preparations are stable, easy to prepare and good partitioning between oil and water.
