- 1. Rooms are allotted to the students by the Hostel Authorities. However, the management reserves the right to change any room/rooms with a short notice.
- 2. Whoever admits in the hostel should opt both for boarding and accommodation. If a student is staying away from the hostel for one or more nights, he/she should get the permission of the concerned hostel warden.
- 3. Hostel admission will be given semester-wise based on the payment of mess bill in advance and clearance of previous dues.
- 4. Four and two-wheeler motor vehicles are strictly not allowed in the Hostel premises as it leads to sound and air pollution, creates problem and disturbance to fellow boarders. However, bicycles are permitted, and these are to be kept in the respective Hostel cycle stand only.
- 5. Consumption of Alcohol, Drugs, Smoking and any other unwanted items in the Hostel premises is prohibited; violation of this may lead to expulsion from the hostel.
- 6. The boarders shall refrain from music and singing or making noise in the Hostel during the hours when students devote the time to study, strict silence is to be observed during study hours.
- 7. Students are responsible for the safety of furniture, electrical fittings and other fixtures in the rooms, and these should be properly handed over at the time of their leaving to the concerned Hostel Warden.
- 8. Ragging is an offence, and it is prohibited by the state as well as Central Government. Students who indulge in ragging or other acts of the misconduct are liable for severe punishment including expulsion from the hostel immediately and from the College.
- 9. Disseminating information to the press and electronic media/platform without prior authorization from the relevant authorities that result in defaming the institution, is strictly prohibited. Such actions will lead to immediate expulsion from the hostel, and the college authorities will be recommended to take stringent disciplinary measures against the offending student.
- 10. Use of electrical appliances such as heaters for cooking food, water heaters, iron box, etc. in the room is strictly prohibited.
- 11. Indoor games are likely to disturb the adjacent inmates and are prohibited in the rooms and playing cricket inside the hostel premises is also strictly prohibited.
- 12. The boarders shall not issue any orders to the hostel servants and shall not interfere in their work. In case of misconduct or unsatisfactory service on the part of the servants, boarders shall not take law into their own hands, but shall immediately report to the Hostel Office/ concerned Hostel Warden.
- 13. Boarders shall not put-up notices or convene meeting of any sort within the hostel premises without the prior permission from concerned Hostel Warden.
- 14. Any boarder, who has been suspended/expelled from the College, shall deemed to be expelled from the hostel automatically.

- 15. Guests are not allowed to stay in the hostel without prior permission under any circumstances, Boarders who allow guests are liable to be suspended from the hostel and a fine of Rs.500/- per day will be levied.
- 16. Misconduct, disobedience to the hostel authorities, breach of hostel rules shall result in fine, suspension or dismissal from the hostel.
- 17. Boarders are advised not to keep rooms unlocked while going out and do not keep money or valuables in your rooms (Cell phones, Computers, Gold etc.). Hostel authorities are not responsible for lost goods/ money/valuables if any.
- 18. Boarders are also advised not to take the food into their rooms or TV room etc. If they indulge in such activity, disciplinary action will be taken and may lead to expulsion from the Hostel.
- 19. Hostel mess bill (excluding scholarship amount if any) should be paid semester-wise in advance before the commencement of academic year. Boarders must pay mess charges every month within 15 days from the date of display of mess bill. If any boarder is failed to pay mess charges in the specified time, he/she must pay the penalty of Rs.20/-per day, a maximum of 30 days from the date of display of the mess bill. After 30 days, the penalty shall be collected on the actual mess dues at the rate of 2% (two percent) for every month up to a maximum period of three months. Thereafter, he/she will forgo the hostel admission. Those students who wants to take re-admission in the hostel, he/she must pay Rs. 500/- towards re-admission charges.
- 20. Due to limited hostel accommodation, priority will be given to the students who clear the subjects at a time in subsequent semesters.
- 21. The students who are eligible for scholarship are required to pay the difference amount of monthly mess bill. Caution and mess deposit should be paid at the time of admission, and this will be refunded at the time of vacating the Hostel.
- 22. If any unauthorized persons (non-boarders) found in the hostel during the inspection by University/College officials, those persons shall be handed over to the police and the boarder who entertained the unauthorized person shall be expelled from the hostel.
- 23. Students who detained due to shortage of attendance/credits shall forgo Hostel admission and should not enter the hostel premises without the written permission from the College/University. Violation of this shall lead to expulsion from the college. The detained students who got re-admitted/re-registered for the course are required to apply afresh for hostel admission based on the availability of accommodation.
- 24. Hostel rules and the regulations framed by the hostel committee from time to time will apply to all boarders.

I have read all the hostel rules & regulations and I abide by the same. If, I violate any of these rules, my hostel admission is liable for cancellation.

# PROCEDURE FOR ACQUIRING HOSTEL ADMISSION

- 1. Students seeking hostel admission should collect the application form from the Hostel Office.
- Filled in application form along with a challan of <u>Rs.100/-</u> towards application fee shall be submitted at the hostel office.
- 3. Challan form and bank details can be collected from the hostel office.
- 4. The following photocopies of documents shall be submitted along with application form:
  - a. College / Campus allotment letter.
  - b. Income / Salary certificate or Pay slip of Parent.
  - c. Aadhaar card
  - d. GATE/SCORE/EAMCET/ECET/ICET rank card.
  - e. Residence certificate or Parent address proof
  - f. SSC, Inter and Degree marks memos.
  - g. Student study certificate from IV to till class.
  - h. Caste certificate
  - i. Passport size photos (4 Nos)
- 5. The short-listed applicants for hostel admission need to pay prescribed caution and mess deposit (refundable) and administrative charges (non-refundable) as detailed below to confirm their final hostel accommodation.

# **Criteria for Hostel Admission**

Based on the available vacancies with the existing infrastructure, the following criteria has been suggested for making hostel admission for students who are admitting for the academic year 2024-2025.

## For UG Programmes (Boys/Girls):

The hostel admission may be given to the students whose parental income Rs.1,50,000/- for OC/BC (eligible for scholarships) and Rs.2,00,000/- for SC/ST (eligible for scholarships) and the distance from the residence is more than 50 km from the college based on the address given in the Aadhar card. The following order of priority may be followed:

- 1. B Tech 4 year Programs (Regular), i.e. CE, ME, EEE, ECE, CSE, Met. E and Chem. E.
- 2. B Tech + M Tech IDP 5 year programs (self-financed), i.e. CE, ME, EEE, ECE and CSE.
- 3. B Tech 4 year Programs (Self-financed), i.e. CSE(AIML), CSE(CS), BT and GE.
- 4. BBA 3 year Program (Self-financed)
- 5. If further vacancies are available, hostel facility may be extended to the students based on the parental income for available vacancies.

#### For PG Programs (Boys/Girls):

The hostel admission may be given to the students whose parental income Rs.1,50,000/- for OC/BC (eligible for scholarships) and Rs.2,00,000/- for SC/ST (eligible for scholarships) and the distance from the residence is more than 50 km from the college based on the address given in the Aadhar card. The following order of priority may be followed:

- 1. GATE qualified students of M Tech (Regular category)
- 2. NET/CSIR or any other National level qualifying examination MSc, M Pharmacy, etc. (Regular Category)
- TS PGECET, TS ICET and other State level qualifying examination of M Tech, MBA, MCA (Regular Category)
- 4. Self-financed Category of all PG Programs
- 5. If further vacancies are available, hostel facility may be extended to the students based on the parental income for available vacancies.
